Will the Minister of FINANCE be pleased to state:

(a) the details of total loans granted under Pradhan Mantri Mudra Yojana (PMMY) and PM SVANidhi to different States of the country during the last three years, State-wise including Maharashtra and Karnataka;

(b) whether any survey has been undertaken by the Government regarding the number of beneficiaries across manufacturing and trading sectors under PMMY and PM SVANidhi during the said period; and

(c) if so, the details thereof?

(a) As per data uploaded by Member Lending Institutions on Mudra portal, more than 16.67 crore loans with a sanctioned amount of Rs. 9.98 lakh crore have been extended in the country during the last three years (from F.Y. 2019-20 to F.Y. 2021-22), under PMMY Scheme.

As per data received from Ministry of Housing and Urban Affairs, more than 47.94 lakh loans with a sanctioned amount of Rs. 5,958.34 crore have been extended in three tranches under PM SVANidhi Scheme in the country since the inception of the Scheme, i.e., from 01.06.2020 to 05.03.2023.

State-wise details of loans under PMMY and PM SVANidhi, including State of Maharashtra and Karnataka, is at Annexure.

(b) and (c) Sector-wise data is not centrally maintained.
